4. FIRST AID MEASURES

- 4.1 Description of first aid measures**
In all cases of doubt, or when symptoms persist, seek medical attention.

If ventilation during spray-application is insufficient, use appropriate certified respirators with gas, vapour and dust filter AP.

Always wear protective gloves.

Barrier creams may help to protect the exposed areas of the skin, they should however not be applied once exposure has occurred.

Gloves should be replaced regularly and if there is any sign of damage to the glove material. The instructions and information provided by the glove manufacturer on use, storage, maintenance and replacement must be followed. Recommended protective glove type is e.g.:

nitrile rubber (breakthrough time > 480 min.)

PVA gloves are not recommended.
